**AND UPON** reading the witness statement of Emilie Bladon dated 12 January 2024.

**IT IS ORDERED AND DIRECTED THAT:**

1. The Claimant do by **26 February 2024** send notification to the persons listed in Schedule 1 of this order (at the email addresses set out in the said Schedule 1) of the commencement of these proceedings and provide each of them with a copy of the statements of case filed and a sealed copy of this order.
2. Any of the persons so notified who wish to pursue a claim to the monies that have been held in the account of the Defendant numbered 53807290 (“the Account”) shall by 4pm on **18 March 2024** file and serve on the parties a witness statement with a signed statement of truth comprehensively setting out:
  - a. Confirmation of their wish to pursue their claim to the monies that have been held in the Account and their wish to be joined as a party.



- b. The factual and legal basis of their claim to the monies that have been held in the Account.
  - c. The quantum of their claim to the said monies.
  - d. The basis upon which they contend that they ought to be joined as a party.
3. There be a further hearing with a time estimate of 2 hours on a date after 08 April 2024 for further directions.
  4. Costs in the case.
  5. The Claimant shall serve a sealed copy of this Order on the Defendant.
